HSR Training Private Courses Face to Face Delivery

SafeWork NSW Approved

SafetyWork's 5-day HSR Course and 1-day HSR Refresher Course have been developed specifically for current Health and Safety Representatives (HSRs) and Deputy HSRs who have been elected under Part 5 of the WHS Act 2011. The remote training will be delivered live via video streaming. Participants need to attend and participate in all scheduled live sessions in order to receive a certificate of completion.

This SafeWork NSW approved course will assist HSRs to gain the knowledge and skills needed to fulfill their role and functions under the WHS legislation. The role of the HSR is to facilitate the flow of information about health and safety between the Person Conducting a Business or Undertaking (PCBU) and the workers in their work group.

A HSR who has completed the 5-day HSR Remote Connected Delivery Course will be deemed to have undergone the training prescribed by the Workplace Health and Safety Regulations 2017, for the purposes of issuing a direction to cease unsafe work under section 85 and issuing a provisional improvement notice under Section 90 of the WHS Act 2011.

Course Content

Upon successful completion of the 5-day remote training, participants will understand the principles of:

- Work Health and Safety Framework and legislative requirements.
- Consultation, Representation and Participation.
- Role of the HSR in Issue Resolution and minimising risks.
- Inspections, Notifiable Incidents and Incident Investigation
- Provisional Improvement Notices and directing unsafe work to cease.

The 1-day course includes all elected HSRs under the WHS Act who have previously completed the approved initial five day training course. Participants will refresh their understanding of their roles, powers and functions in the representation, monitoring, investigation and enquiry into work health and safety management at their workplace under the WHS law.

Who Should Attend?

Anyone can attend the 5-day SafeWork NSW Approved HSR Course and obtain a certificate. However, only current elected or “deemed” HSRs can exercise the power of issuing Provisional Improvement Notices (PINs) or directing that unsafe work cease.

Elected HSRs and deputy HSRs are entitled to attend the five day online training course in work health and safety. In addition they are also entitled to attend the one day refresher course each year during their term of office. The HSR training courses can also be accessed by other members of your organisation such as health & safety committee members, managers & supervisors to assist them in understanding the legislative requirements relating to consultation in the workplace.

Evidence of Identity (EOI)

All participants enrolled in the 5-day course must provide evidence of identification as specified by SafeWork NSW. EOI documents must be originals, and provided to your trainer one week before the course commences. Documents must be issued by a government agency or a financial institution, and contain your name, date of birth, residential address, photo and signature.
